

## Montana Dance Works Birthday Party Contract

### MDW will provide:

- ❖ 2 hours in our state-of-the-art facility!
- ❖ Opt in for 45 Minutes of instructed dance, fun & games in the studio **OR** Bounce House Party (no instruction)
- ❖ 45 Minutes in the lobby for opening presents, serving cake, etc.
- ❖ 2 six foot tables, approximately 15 chairs

### You will provide:

- ❖ Provide all food, beverages & party favors. No alcohol allowed on studio premises.
- ❖ Provide and set up any desired decorations for the lobby. (Included in rental time)
- ❖ Provide all take down and clean-up of any decorations, party favors, food, beverages, etc.
- ❖ Provide a nonrefundable deposit of \$50.00 to reserve party date/time.
- ❖ Inform your guests and their guardians of the guidelines and considerations associated with participation at a birthday party held at Montana Dance Works.
- ❖ Limit 12 participants. \$15 per participant after 12, max 20.
- ❖ Each participant must complete a signed waiver.
- ❖ Montana Dance Works has rented the lobby and one studio for your use during the above scheduled time. There may be another event preceding or following your event. It is imperative that your event finishes in the scheduled time frame. This includes all children being picked up on time. Children who are not picked up on time are your responsibility and may not be left on the premises without adult supervision.
- ❖ Street shoes are **NOT ALLOWED** on the dance floors. If the children who are participating do not have dance shoes, they are welcome to wear socks or go barefoot.

### Payments:

- ❖ Total Party Cost :
    - Facility only \$100.00
    - Dance/Tumble Instruction **OR** Bounce House - \$150.00 includes 12 participants. \$15/per participant after 12. Max 20.
  - ❖ A \$50.00 nonrefundable deposit is due to upon returning this contract and to hold your requested date/time.
  - ❖ The remaining balance is due prior to birthday party start time.
  - ❖ If notice is given more than 48 hours prior to the scheduled event, the deposit may be applied to schedule an alternative time for the event. If a birthday party is cancelled within 48 hours of the scheduled event, the deposit is forfeited. **THE DEPOSIT WILL NOT BE REFUNDED FOR ANY REASON.**
